The Electric Press dominates Millennium Square which is a focal point for events in Leeds City Centre. A program of past and future events is available upon request. The Grade II listed building is home to an eclectic selection of restaurants offering a wide range of cuisine, along with several bars serving champagne and fine wines to beers and cocktails. Home to Be At One, Revolution and Red Chilli, the Electric Press provides drinking and dining options for all occasions.
